## China State Construction International (3311 HK)

**BUY** (from Neutral)

### Firm Earnings, Improving Cash Flow; U/G BUY

Target Price (Return) HKD9.30 (+16%)  
 Price: HKD8.03  
 Market Cap: HKD40,545m

- **Upgrade to BUY from Neutral with a new HKD9.30 TP** from HKD 8.56, 16% upside plus 4% yield based on 8x 2019F recurring P/E, -1SD of the 3-year forward mean. TP is backed by HKD8.70 DCF valuation – fair, considering better market liquidity and sustainable funding to support 10.5% topline and 16.2% bottomline growth over the next three years. On 18 Apr, China State Construction International posted 1Q19 operating revenue and pre-tax profit of HKD12bn (+0.4% YoY) and HKD2.17bn (+20.4% YoY), driven by expanding pre-tax margin.

- **2019 may see earnings recovery at 33% YoY**, as the HKD819m one-off impairment loss was booked in 2018. Future revenue and earnings growth is also solid, estimated at CAGRs of 10.5% and 16.2% in 2019-2021. We see CSCI shifting from a public-private partnership (PPP) business model towards cash construction and investment projects in Hong Kong and Macau – this drops GPM, but comes with better operating cash flows and easing debt pressure. As long as there are JV earnings, net profits should go faster than revenue. We cut out 2019-2020 JV earnings 41% and 48% to reflect the company's intention to constrain revenue from PPPs in the future. Topline increase is driven by Hong Kong and Macau backlogs of HKD51.12bn as at end-1Q19, strong enough to sustain revenue growth.

- **1Q19 results beat consensus expectations**, with pre-tax margins up 4.2ppts YoY. Revenue and pre-tax profit of HKD12bn and HKD2.17bn were up 0.4% and 20.4% YoY. The former was due to slower infrastructure progress in Mainland China. Conversely, Macau and Hong Kong projects started to contribute decent earnings, especially high-margin investment projects, which drove up earnings significantly. 1Q19 new contracts stood at HKD34.6bn (+5% YoY), comprising HKD14.87bn from Hong Kong (43%) and HKD16.12bn from Mainland China (47%), in line with CSCI's strategy to shift to the Hong Kong market. We believe the company is on the right track, shifting from slow-payback PPPs to cash generators in Hong Kong and Macau. Currently, CSCI has c.HKD85bn PPPs in hand, 33.3% of its total backlog in 1Q19, down from 33.8% in 2018.

- **Bet on future fundraising.** The current loosening liquidity environment benefits CSCI's asset-backed securities issuance, which may accelerate PPP cash inflows. In Dec 2018, the company issued a perpetual bond of USD500m. In Mar 2019, it completed asset securitisation financing of USD500m.






